### **Rush County Receives Lilly Endowment Inc. GIFT VII Opportunity!**



Rush County Community Foundation has received a grant of \$500,000.00 as part of Lilly Endowment Inc.'s seventh phase of its Giving Indiana Funds for Tomorrow (GIFT) initiative. With GIFT VII, the Endowment is making up to \$125 million available to help Indiana community foundations strengthen the towns, cities and counties they serve.

Rush County Community Foundation can use this matching fund grant to build our financial assets and support our charitable activities. The matching fund grant will be designated to support the growth of Rush County Community Foundation's unrestricted endowments, which over time will provide

flexibility to help the foundation to meet community needs. **The Endowment will provide \$2 for every \$1 contributed to Rush County Community Foundation's unrestricted endowments during the matching period, October 1, 2018, through December 31, 2020. [Read more details here.](#)**
